Nou kontinyen lo paz 8, dan definisyon pou *blockchain* lo trwazyenm laliny nou'n retir "is" e nou'n ranplas li par "are".

HON JOHAN LOZE

Mersi Mr Speaker. Mr Speaker, mon ti zis pe sers en klarifikasyon avek FSA pou 4(2)(c) esansyelman; -

“to approve the registration of scheme involving an initial coin offering or non-fungible asset”

Mon ti annan zis en kestyon zot pe zis *register*, zot pa pe *licence* sa *coin* li menm, be si sa lakonpannyen ki pe *issue* sa *coin offering*, i pe lans en *token* ki *closed* e ki vin en lakonpannyen *on a blockchain* dan li menm. I pa parti sa lakonpannyen, sa *coin* ki li i pe lanse be sa *token* ki i pe lanse i pa form parti son lakonpannyen i vin endepandan e i vin en lakonpannyen dan li menm *on the blockchain*.

Zis *registered* e i *unlicenced* prezan mon pe gete si zot annan en provizyon pou sa. Mersi Mr Speaker.

MR SPEAKER

Mersi. Nou annan en lesplikasyon lo lapar *panel*. Minis, kekfwa si ou endik en manm *panel* i zis lev lanmen pou mwan rekonnet li. Byen, *yes sir, go ahead please*.

Sa lakonpannyen ou endividé i pou kre son *scheme* ki pou kre son *coin* atraver en prosedir ki en *initial coin offering* ki pou vin kot nou kot Lotorite Servis Finansyel ki pou anrezistre,

Prezan *once* ki i anrezistre sa *coin* avek sa *NFT*, i pou bezwen al kot en *licensee* ki anba sa Lalwa i pou en VASP li menm li *or* en *licensee* anba *Securities Act* ki pou kapab *market* e promot sa *NFT* *or* *coin*. Sa *coin* avek *NFT* orizinalman i pou ganny kree atraver en *blockchain* son prosedir normal.

HON JOHN HOAREAU

Yes Mr Speaker, nou lo paz 12 anba subsection (o).

Parey mon'n dir nou retir sa mo "a" apre sa mo "where" dan dezyenm laliny e lo trwazyenm laliny nou retir "s" avek "arises" so i lir koman "arise". (p) sivre sa i vin (p), nou retir sa mo "the" apre "with" lo premye laliny e osi "authorities" dan plas "authority", so nou pe met "ies" e nou pe retir "y".

Nou proceed to (q) kot komansman fraz nou pe met 'to'.

Nou al aprezan lo menm paz menm anba 'licensing' Speaker Onorab Georges i annan en pti keksoz pou dir.

MR SPEAKER

Onorab wi, mon war ou lanmen prezant. Wi, Onorab Georges.

HON BERNARD GEORGES

Mersi Mr Chair. Bonzour Mr Chair, bonzour tou dimoun. Mr Chair, eskiz mwan, mon retourne en pti kou lo paragrap (o) lo paz 12, eskiz mwan mon pe sey regarde si vreman sa "s" dan "arise" i devret tire.

"Where a reasonable suspicion of criminal activities arises" sa mon konpran akoz i enn, me ler nou met "where is reasonable suspicion of

criminal activities arise" eski i fer...

MR SPEAKER

Ou pe dir subject "is suspicion of criminal activities."

HON BERNARD GEORGES

That's right, that's exactly right, swa fodre si nou tir sa "s" mon krwar nou bezwen met "suspicions" in the plural "where reasonable suspicion or criminal activities arise". Ou konpran mwan?

MR SPEAKER

Wi, mon ti a sizere ki mannyer pli fasil se retourne lo *wording original*, i zis en pti koreksyon grammar Onorab Hoareau e si napa okenn obzeksyon lo Manm oubyen panel ki nou retourne lo *original* "suspicion arises", akoz "suspicion" i en singular.

HON JOHN HOAREAU

Ok, so nou met sa "a" apre "where a reasonable suspicion of criminal activity arises".

MR SPEAKER

Thank you, mon krwar nou dakor lo la. Ou kapab kontinyen.

HON JOHN HOAREAU

Ok, nou kontinyen avek anba licensing 5(1) dezyenm laliny apre sa mo "herself" nou'n azout "or itself".

Apre lo trwazyenm laliny apre sa mo “from” nou retir “the Seychelles” nou kit li “from Seychelles”.

MR SPEAKER

Un instant, wi, Onorab Loze?

HON JOHAN LOZE

Yes, Mr Speaker. Sorry, mon'n zis en pti pe pli devan sa ki mon ti pe demann ou, akoz mon ti pe lev lanmen boner pou ou ganny letan war mwan, mon kestyion pou FSA i lo 6(3) “for the purpose of the following Act, persons are eligible for a licence as virtual...”

E sa 2 kategori “a” ek “b” ki ganny cited se a company incorporated anba Companies Act apre an international business, mon oule zis fer kler la en Seselwa e letan mon pe koz lo Seselwa, en Seselwa, en endividé ki pa hold licence pou either, en lakonpannyen registered anba en international business, ouswa 1972 Companies Act, ou pa liable pou ki anrezistre en VASP avek FSA unless ou hold enn ant sa 2 licences. Mersi Mr Speaker.

MR SPEAKER

Mersi. Nou a pran komanter panel lo la si i annan. Mr Samson. question mark

Onorab, mersi pou ou kestyion. So the requirements pou ou kapab apply pou en licence, you need to be registered either as a Domestic Company 1972 or as an IBC, so koman en endividé en natural person you would not be able to, so that is...

MR SPEAKER

Thank you. Mersi pou ou leksplikasyon. Onorab Hoareau nou...

HON JOHN HOAREAU

Nou retourne lo paz 12 5(2) anba licensing, ankor 5(2) “no person shall be” - “shall” sorry, “no person shall in or any form”, sorry mon a relir sa; -

“no person shall in or from” nou retir “the Seychelles” nou kit li koman “Seychelles” apre nou retir apre sa mo ‘Seychelles’, “be permitted to”.

Nou al aprezan lo paz 13 anba 6(1) dezyenm laliny apre sa mo “licence” nou retir “can” e nou met “may”.

Nou al aprezan lo paz 14 anba subsection 4(d) nou retir, sorry, nou'n azout “satisfies the authority that it” lo komansman e apre i kontinyen avek son wording “will be able”.

Prezan nou al lo (h) anba subsection (h) satisfies the authority that an approval is in the public interest having regards” nou retir sa “s” avek “regards”.

Nou al aprezan lo paz 15 anba subsection (7), trwazyenm laliny nou retir sa mo “reasonably” apre sa mo “or”, apre i kontinyen “should” la aprezan nou remet sa mo “reasonably” apre “should” ki fer li lir en pti pe pli byen.

E answit lo dernyen laliny sa clause apre sa mo “fine as” nou’n met “is”, so “fine as is specified under section 33”.

Prezan nou al lo anba conditions attaching to licensee, to licence sorry anba paz 15 menm 8(2), 8(2) nou’n retir en whole paragraph e i pou lir koumsa; -

“a licensee shall at all times its licence on display at it’s principal place of business in the Seychelles, in Seychelles and the licence...”.

MR SPEAKER

Mon war Minis in lev lanmen, Minister, nou a les li fini oubyen ou komanter i vin avan?

MINISTER NAADIR HASSAN

Mersi Mr Chair. Non, mon ti oule go back to en seksyon, i annan en mo ki pe fatig mwan en pe, ki mon pa war e mon pa

tro krwar i *the right wording*, lo seksyon 7(4)(b) kot nou pe dir “satisfy the authority that will be able if licenced to comply with any financial resources”.

Mon krwar the proper wording here should be “with any financial obligation,” sa mo “financial resources” pa pe antre byen la. It should be “financial obligation”.

MR SPEAKER

So, Onorab Georges?

HON BERNARD GEORGES

Etandonnen ki Minis pa kapab - mersi Mr Chair - etandonnen ki Minis pa kapab propoz en lamannman, eski mon kapab demann ou permision pou propoz en simple amendment pou sanz resources to “obligations” dan sa paragraf? Mersi.

MR SPEAKER

Wi. So, Minis in - ou pe propoz sa? Okenn obzeksyon ouswa komanter from other members? So sa i annord nou a pran li koman en simple amendment. Ok, Onorab Hoareau ou kapab retourn kot ou ti’n arive.

HON JOHN HOAREAU

Mersi Mr Chair. Wi, nou pe kontinyen lo paz 15.

MR SPEAKER

Wi, ou a rekomans sa seksyon 2.

HON JOHN HOAREAU

Wi, 2 wi, mon ava lir sa seksyon ki mannyer i devret ganny lir.

MR SPEAKER

Un instant. Onorab Gill, ou pwen i vin, *go ahead.*

HON CHURCHILL GILL

Bonzour Mr Speaker. Bonzour tou dimoun. Mon ti lo 8(a) menm i ti zis en klarifikasyon, konmsi rezondet akoz ki (a) ou bezwen limit *number of clients* ki pou ganny *licence*, apre (c) ou limit maksimonm *value* pour sa *individual clients*. Zis rezondet.

MR SPEAKER

8(1)(a) ou pe dir en? Yes. Mr Elizabeth?

HON CHURCHILL GILL

Relasyon avek (c) - 8(1)(c)(2).

MR SPEAKER

Yes, mon konpran ou. Mr Elizabeth, mon krwar. Wi?

MANAGER PRODUCT DEVELOPMENT & RESEARCH UNIT FSA MARCUS ELIZABETH

Mersi Mr Speaker. Si pou reponn kestyon Onorab, *limiting the number of clients*, normalman en VASP son

loperasyon mannyer i *operate* nenport kliyan, kantite kliyan ki kapab *subscribe* pou servi son servis, i annan lenstans kot i annan VASP zot pran bokou kliyan zis *for the purpose of* pou zot pa ganny commission.

Laminizman sa bann *asset laminizman funds* ki i annan, zot pa pe kapab - i tro an kontrol lo zot. Sanmenm sa ki nou'n met serten paramet ki pou regulariz kantite kliyan ki en *licensing* pou kapab *operate*.

Akoz i annan ki oule fer bokou larzan pou *commission* e zot pratik i pa neseserman anliny avek standar en *requirements*. So sa i pou permet nou kapab etablir kantite kliyan son maksimonm ki i pou kapab servi.

Kot i konsern son *value*, son kalite servis osi ki i kapab ofer, akoz VASP li menm li son servis i kapab fer i dinamik i kapab sanze preski toulezour, alors i devret pe kapab *operate* fer servis pour ki i ganny otorize anba son *licence* ki i pou gannyen.

So nou pe spesifye ki nou kapab fer sa servis, lakantite kliyan e si ou al an deor sa la ki nou kapab antre pou prezan bann aksyon *reinforcement* avek zot. Sa i vin koman en kondisyon zot *licence*. Si zot santi ki zot kapab al plis zot

demonstre avek lotorite kot zot kapab servi plis kliyan pou fer plis servis e la nou, nou konsidere pou donn zot sa permision. Mersi Mr Speaker.

MR SPEAKER

Thank you. Wi, Mr Samson, i oule azoute?

CEO FSA RANDOLPH SAMSON

Mersi Mr Speaker. Apre pou konplimant larepons mon koleg, sa seksyon la i osi tou i *provide* pou en eleman *consumer protection*. Parey nou konnen dan lenvestisman i annan diferan kalite lenvestiser. I annan lenvestiser lenstitisyonnal avek bann ki *retail*.

So lo kote sa bann konstitisyon, Lotorite i annan sa diskresyon pou regarde si sa lakonpannyen petet i pe *serve* bann lenvestiser *retail* ki zot, zot napa *as much* ledikasyon *as* bann *institutional investors of clients*, then i kapab annan serten kondisyon pou limit en pe aktivite ki sa bann VASP pe *carry out*. Mersi.

MR SPEAKER

Mersi. Mersi pou ou lesplikasyon. Onorab Hoareau.

HON JOHN HOAREAU

Mersi Mr Chair. Mr Chair, mon ava relir sa bout ki mon'n komans lir taler - mon'n arete.

Annefe nou'n bezwen met li an *listed format* akoz i menm keksoz ki'n ganny mete dan sa paragraf ki nou'n retire, me selman nou'n bezwen met li an *listed format* an vi ki i annan bokou bann diferan eleman ki i bezwen ganny *listed*.

"A licensee shall at all times keep its licence on display at its principal place of business in Seychelles and the licence shall include the following licensing information;

- (a) *The date upon which the licence was issued*
- (b) *The associated licence number*
- (c) *Any other business or trade name by which the licensee is known*
- (d) *The conditions attached to the licence*
Kontinyen lo lot paz 16.
- (e) *The activities for which the licence has been issued*
- (f) *Activities which are unlicenced by the authority*
- (g) *The address of the principal place of business or in Seychelles.*

MR SPEAKER

Nou ava aret la pou le moman, Minis in lev lanmen mon'n

prefere les Onorab Hoareau fini lir son paragrapf pou pa retourn lo la. Minis ou premye?

MINISTER NAADIR HASSAN

Mersi Mr Chair. Mon pe zis lir premye bout sa *clause*, mon krwar i annan en bout ki nou kapab tire; -

“A licensee shall at all times keep its licence on display at the principal place of business in Seychelles and the licence shall include the following..”

Mon pa war li neseser pou met “licensing information” akoz nou konnen nou pe koz lo “licensing information’ la i vin ne repetisyon ki pa neseser, mon ti ava kekawa mazinen nou ti kapab fini sa fraz “shall include the following”. Mersi.

MR SPEAKER

Mon krwar nou kapab war li koman en senp *amendment*, Manm i oule adres lo sa pwen spesifik premye? Onorab Georges?

HON BERNARD GEORGES

Mersi Mr Chair. Mr Chair, non, mon pa pe adres lo sa pwen, me mon annan enn de lezot propozisyon lamannman pou fer. Mersi.

MR SPEAKER

Ok, be les nou a fini dil avek sa pwen Minis pe sizere ki nou *delete “licensing information.”* Oule fer sa lamannman Onorab Georges lo lapar Minis?

HON BERNARD GEORGES

Wi, les nou fini sa enn Mr Chair mon dakor avek ou. Mon propoze ki sa 2 mo “licensing information” well, first of all permet mwan pou move en amendment to the amendment pou delete sa mo - sa 2 mo “licensing information” dan chapeau of the proposed new subclause 2. Mersi.

MR SPEAKER

Thank you. Okenn komanter other members, napa lobzeksyon ki nou tret sa koman, Onorab Pillay, ou lo sa pwen?

HON SEBASTIEN PILLAY

Wi, wi Mr Chairman. Mon konpran rezondet akoz ki nou oule *delete* sa mo “licensing information” akoz sa bann keksoz ki pe liste i deza bann lenformasyon.

Me selman mon ti a kontan panel i klarifye en keksoz anler nou'n dir poudir sa licence pou ganny display dan its principal place of business and then nou ranforsi poudir the licensee shall display such information

on its website in an permanent manner.

Prenon kont ki Onorab pe propoz *delete “licensing information”* mon ti a zis demann FSA pou klarifye *how practical* i pou ete e ki kalite dokiman ki pou kapab *display* tou sa bann keksoz *prominently physically?*

Par egzanp en *retailer* ozordi i *display* son *retail licence* - i zis en senp dokiman, mon pwen i se ki i pou difisil pou en dimoun *display* tousala dan en sel dokiman e dan ki *format* i pou ganny fer?

MR SPEAKER

Mersi. So mon *assume* ki nou'n aksepte sa lamannman, Manm pa'n obzekte, Minis, *panel* nou a pran pwen Onorab Pillay?

CEO FSA RANDOLPH SAMSON

Mersi Mr Speaker. Mersi Onorab Pillay. So ordinerman nou bann *licence certificate* i pou *include* tou sa bann lenformasyon ki'n ganny liste la e petet lo kote *website* osi tou, nou pou bezwen fer sir ki sa bann lenformasyon in ganny reflekte, akoz *again* zis pou montre sa bann l'investiser *the public* poudir *actually* sa antite i *licensed*. E apre i annan *website* FSA osi tou ki dimoun i kapab al lo la pou gete.

MR SPEAKER

Wi, Onorab Pillay?

HON SEBASTIEN PILLAY

Zis mon pe demande Mr Speaker avek Minis.

But then isn't 3 surplus to requirements, akoz ou pa zis dir anler dan 2 al its increased per place of business and on its website in Seychelles and on its website - konmsi ou ti'n kapab met tousala dan sa chapeau ou rather ki ou bezwen dir poudir ki ou bezwen display dan son permanent place of business e dan son website.

Mon pe zis dir be si in ekrir koumsa nou pou al sanz sa *then* i pou bezwen re inanim li pou vin en problem pou nou. Plito nou kit li parey i ete,

MR SPEAKER

Wi, mon krwar al *reward* sa i vini en problem e *it can turn into a major amendment*, so si ou'n aksepte lesplikasyon Mr Samson nou a kapab... Wi, Onorab Hoareau?

HON JOHN HOAREAU

Mon pe realize poudir anba (g) i annan en "or" ki pa sipoze la, so "*the address of the principal place of business*" i annan "or in Seychelles" sa "or" i sipoze retire mon mazinen.

MR SPEAKER

Ok so it's a licence address to the place of business, korek sa? Panel i ale avek lentansyon. Minis.

MINISTER NAADIR HASSAN

Mersi Mr Chair. Mr Chair, mon dakor sa "or" i kapab sorti. Mon mazinen sa i en mistake sa.

MR SPEAKER

Ok, Manm i aksepte? Good. Onorab Georges.

HON BERNARD GEORGES

Mersi Mr Chair. Mr Chair, mon annan detrwa pti amendments to amendment, me zot vreman minor ou ava eskiz mwan.

Dan sanmenm sa clause ki nou pe regarde dan paragraf (b) i mank en semi column at the end alor mon pe move ki nou met enn.

Dan dernyen fraz wi sa mo "or" in sorti me mon ti ava propoze ki nou repet "the address of the principal place of business of the licensee in Seychelles" akoz just to pou nou pa annan okenn konfizyon which principal place of business it is.

E "at the end of Seychelles", nou bezwen en full stop e non pa en comma parey i ete la.

E pandan sa ki mon annan laparol avek ou

permisyon mon ava sot lo subclause 3 e la osi propoze ki i annan en full stop at the end apre "manner". Mersi.

MR SPEAKER

Ok, so sa 2 full stop mon krwar i straight forward, eski nou annan okenn pwen oule azout place of, oule azout "the licensee" after "place of business"? Eski panel i war okenn konplikasyon la?

Yes, Legal Draftsperson mon krwar, wi. Madam.

Thank you Mr Speaker. I would just like to note that under subsection 3 we might need to add "referred to" in subsection before the identification of subsection 2 so that it reads "the licensee shall display such information referred to in subsection 2 on its website in a permanent manner".

MR SPEAKER

Onorab Georges?

HON BERNARD GEORGES

Mersi Mr Chair. Mr Chair, permet mwan fer sa 2 propozisyon swivan. Annefe mon premye lentansyon sete

dan (g) pa pou repet “*the licensee*” me pou dir “*the address of its principal place of business*” e sa pou fer sir ki se sa *business the principal place of that business* ki nou ti pou mete.

So mon pe propoz sa koman en alternativ pou konsiderasyon *panel*. E avek ou permisyon swiv sa ki *Legal Draftspersons* in dir, mon propoze ki mon *move* en *amendment to an amendment* dan *subclause 3* pou lir; -

“The licensee shall display such information as is provided in subsection 2 on its website in a permanent manner.” (full stop)

MR SPEAKER

Permet mwan, ou krwar “*provided*” is the right word there or “as is required in?” Ki ou mazinen Onorab Georges?

HON BERNARD GEORGES

I’m happy with “required”, what about the Legal Draftsperson I think she used the word, what was the word you proposed?

ASSISTANT PRINCIPAL LEGISLATIVE DRAFTSPERSON OF LEGAL AFFAIRS DONNA MUGANHIRI

Through you Chair. I had proposed provided in “information referred to”...

HON BERNARD GEORGES

“Referred to”? Thank you.

MR SPEAKER

Thank you. Ok Manm i annan okenn lot komanter lo la, nou aprouve? Ok, this is approved. I don’t see any objections from other members, any comments. So Onorab Hoareau ou kapab reprenan?

HON JOHN HOAREAU

So (3) pou lir koumsa Mr Speaker koriz mwan si mon mal; -

“A licensee shall display such information as is referred to in subsection (2) on its website in a prominent manner.” (full stop)

MR SPEAKER

Thank you.

HON JOHN HOAREAU

Ok, nou al lo clause 4 dan plas 3, so akoz nou’n annan en new 3 so nou renumbered as 4 nou komans avek; -

“Notwithstanding subsection (1) apre nou al avek en nou komans “It” avek en small “i”.

Nou al aprezan lo subsection b(2) furnishing nou retir “*adequate*” nou met “*necessary and reasonable*”. Apre dan trwazyenm laliny nou retir “*work*” nou met “*regulatory functions*”.

Dan sa ka nou retir sa original 4 ki ti la e i vin 5 e nou retir sa premye laliny sa premye 2 laliny prezan nouvo 5 pou lir koumsa; -

"The Authority may by written notice to the holder of the licence amend or revoke any of the conditions imposed under section (1) or attached new conditions provided that the authority shall not impose them without first giving the licensee an opportunity to be heard".

Thank you, Chair. So in light to this provision, it was just trying to sort of create a scope in which legal privilege is being considered.

So it also extends. It's not only to the time but also

extends to a representative of the client, whether it is giving legal advice or during proceedings legal proceedings or for the purpose of ongoing legal proceedings.

So it's as two distinctions in terms of not only to the clients himself or herself but also to their representatives or agent.

MR SPEAKER

Ok, is that clear? Onorab Pillay?

HON SEBASTIEN PILLAY

Mr Chairman, it's not clear. My layman's understanding of attorney-client privilege is that, that privilege is not define unless I am corrected. I don't understand why you would want to define that privilege within this context.

To me this would make the law contrary to the practice of a profession that has already established. We already established that there is a doctor-patient confidentiality and attorney client privilege.

So why would you want to define the circumstances within which something would be considered as privileged information or not. question mark

So are you saying there are all the things that would be considered not privileged

information within that context? And why is this pertinent to you within the regulatory ambit of the law?

I can understand what you want to achieve but why would you want to go that far? Thank you, Mr Chair.

MR SPEAKER

Thank you. Onorab Georges?

HON BERNARD GEORGES

If I may Mr Chair, thank you. Honorable Pillay is absolutely right in terms of what constitutes——privileged communication and what doesn't.

And I'm looking at it, I think I see the reason here and it probably is a mispagination.

If we look here (a) is, as Honorable Pillay says, that's normal privileged communication.

(b) is normal privileged communication.

But I think there should be a (c) and that's probably where the Legal Draftsperson is coming from.

I think that in the second line of paragraph (b) after the word, "or" which follows the semicolon there should be a paragraph and (c) should start by "any person in contemplation of" etcetera.

And that, if that is the case - in any event, does not sit very nicely there, that you have

a semicolon halfway through a sentence and then it carries on.

So if we break it up after “or”, and (c) becomes “by any person in contemplation of” etcetera, that (c) 1 and 2 would not fall into the normal categorization of privileged communication.

And that was probably why it would be brought in. Because it would be an extension of the privilege to an area which is not normally privileged.

And so we are contemplated and we are offering it, that it ok for us to do away with subsection (6) if the interpretation is complicated.

Because legal privilege would still allow - would still apply whether or not we keep the provision or we remove the provision.

MR SPEAKER

Thank you. Onorab Georges, tan ki ou ki’n move – since you move the additional amendments, maybe you can read the proposed wording, so that we can put it on record.

HON BERNARD GEORGES

Mr Chair, what I was – in order to save this provision my proposal would be in (6)(b), to go up to the second line semicolon or and then have a

“c”, which would read “(c) by any person in contemplation of Roman (i) and Roman (ii)”.

Because that (c) would be outside the normal definition of lawyer-client privilege. “(a)” and “(b)” are definitely covered by the normal parlance, the normal definition of lawyer-client privilege. But “(c)” would not.

So if the FSA – (sorry) – if the Minister wishes to retain or to grant legal protection outside of “(a)” and “(b)”, then we would need the “(c)”. If not then we can get rid of all of it. Thank you.

MR SPEAKER

Thank you. Onorab Pillay.

HON SEBASTIEN PILLAY

Mr Speaker, i seldom right, but this time he is. What he is suggesting is that he is trying to save the clause. Because we as the Assembly we do not know what this – we’ve got FATF requirements, you’ve got regulations and whatnot.

And I think this is the concern which are also expressing in that, removing it entirely might move something that somewhere might have a problem for us. So what is suggesting is the best way to do it.

So that you have a “c” that you leave the legal privilege on top but the “c” will

not fall within the ambit of the legal privilege. Thank you.
